The Village of System Care under the We Are All We Need, community revitalization project accepts incoming referrals from 4 main sources; DJJ, DCF, LCS and LCSO Civil Citation to provide Prevention, Intervention & Diversion WRAP around services to young people and their direct caregivers & siblings who are at risk of entering or further matriculating into the Juvenile Justice and/or Child Welfare System.

Purpose: The purpose is to describe the process for accepting & qualifying targeted referrals and connecting these at risk young people and direct caregivers and siblings to The Village Of Care via a personal and culturally competent intake process. TVOC provides early mental health & substance use screening, care coordination, LIFE Coaching & equitable access to necessary tier based services array ranging from Community Based Programming to Behavioral & Mental Health & Substance Use Services and ongoing transition support.

Population of Focus

The Population of focus for The Village of Care Prevention, Intervention & Diversion Program is young people ages 17 and under living in promise zone zip codes and are at risk of increased ACEÕs, High Risk Behaviors, Mental Illness or Substance Abuse, or co-occuring disorders and are at risk of entering or further matriculating through Juvenile Justice and/or Child Welfare System(s).

Eligibility Criteria

Young people will be identified by a referral form that includes identifying information, the name and contact information of caregiver/guardian if applicable and the referral source. Young people who meet at least 2 of the criteria will be onboarded:

- 1. Living in a Promise Zone Zip Code
- 2. Truant Suspended Expelled or Extended Absence due to COVID
- 3. On Probation or Supervised Released or Awaiting Entry to Residential Program
- 4. At Risk of entering Juvenile Justice or Child Welfare due to Exhibiting High Risk Behaviors

- 1. Youth exhibits high risk behaviors in the community or at school without arrest.
- 2. The youth is detained at school or in community and eligible for diversion program.
- 3. The youth is arrested, booked and released on on supervision or probation.
 - a) The Youths assigned LIFE coach will make contact with youth and family to build rapport and a connection. Coach will establish rapport, set goals and milestones and provide information on available Village Services (via the Village Network Providers) to successfully complete established and desired outcomes.
 - b) Based on the villager tier level, the youth and family will work together to create an Individualized LIFE Plan that includes an array of services in which will support the successful achievement of goals & milestones. Goals and Milestones include school IEP or Behavior Plans, Civil Citation or other Diversionary Conditions and/or Probation Terms. Tier 3 youth ILP will also be inclusive of a Clinical Services Schedule.
 - (1) Service Array includes enrollment/access of up to 10 months of:
 - (a) Clinical Mental Health Services,
 - (b) Behavioral Health Services (Substance Abuse),
 - (c) LIFE Coaching,
 - (d) WRAP Coaching,
 - (e) Athletics,
 - (f) Tutoring,
 - (g) Legal Aid,
 - (h) SOAR Housing Aid,
 - (i) Resource Connection and Volunteering.
 - (j) Sample Tier Based Service Array
 - i) Tier 1 Prevention
 - Provided Screening/Assessment
 - (2) Assigned LIFE Coach Group
 - (3) General LIFE Plan
 - (4) Given access to The LIFE Center Events & Services
 - (5) 2 Network Referrals 1 to include mentoring
 - (a) Mentoring & Athletics or Mentoring & Tutoring
 - ii) Tier 2 High Risk Behavior Immediate Intervention (HRBII)
 - (1) Screened/Assessed if one has not been conducted
 - (2) Assigned LIFE Coach Individual
 - (3) Access to Clinical Services
 - (4) Signed Individualized LIFE Treatment Plan
 - (5) WRAP Planning Group & Individual Coaching

- iii) Tier 3 Last Opportunity Support Team (LOST)
 - (1) Diagnosed Mental Illness, Substance Abuse or Co-Occuring Disorder
 - (2) Assigned LIFE Coach Individual
 - (3) Qtrly MDST Meetings
 - (4) Behavioral Health Plan
 - (5) Mental Health Plan
 - (6) Individualized LIFE Plan
- c) Upon agreement to the ILP, the youth will actively participate in their ILPÕs service schedule and provided access to LIFE coach for 10 months in which they will meet
